**Application for Egg Distributor Certificate of Authorization**

for the period July 1, 2014 through June 30, 2015

**§61-7A-2** (WV Marketing of Eggs Rule) The Department shall issue an Egg Distributor Permit to every person distributing eggs in West Virginia. Permits shall be applied for at least thirty (30) days prior to the expiration of the current permit or within thirty (30) days of the date that the person intends to engage in business. The certificate shall expire on the thirtieth (30th) day of June following date of issue.

**The annual permit fee of ten dollars (\$10.00) shall accompany the application for the certificate. A penalty of ten dollars (\$10.00) is added if not applied for or renewed within this time limit.**

**All fees must be paid in U.S. funds drawn from a U.S. Bank, unless the registrant includes an additional \$35 to cover the WV Treasurer's Office handling cost for processing a foreign check.**
